TERMS OF HIRE

- The hirer will take reasonable care at all times while operating the vehicle.
- The hirer may be charged any speeding or parking tickets incurred plus a \$40 admin fee.
- No smoking allowed in the vehicle. A smoking odour may incur a charge of \$50.
- The vehicle must be returned in a clean and tidy state, otherwise a \$50 cleaning fee may be charged. Excessive mud can be removed at little cost by a high pressure water blaster at Shell, Moorhouse Ave cnr Selwyn St.
- Rental days consist of a 24-hour period starting at the time of commencement of rental. Late returns are charged at 25% of retail rate per hour late. Four hours or more late = one day's hire. **Unauthorised late returns will be charged at the daily hire rate plus a 25% penalty.**
- Lost or broken key - up to \$150 plain, \$450 chipped key.
- The vehicle is not to be driven on rough unsealed roads.
- Equipment borrowed or hired will be charged for if not returned, or if damaged.
- If the vehicle is taken to the North Island without the owner's permission, the hirer will be liable for all costs involved in return of vehicle, including any breakdown costs.
- For details of replacement of vehicle or refund in case of accident or mechanical failure see clause 18 on reverse. **No refunds for unused days caused by your change of plan.**

A service fee of \$10 plus cost of fuel will be charged if the vehicle is not returned full.

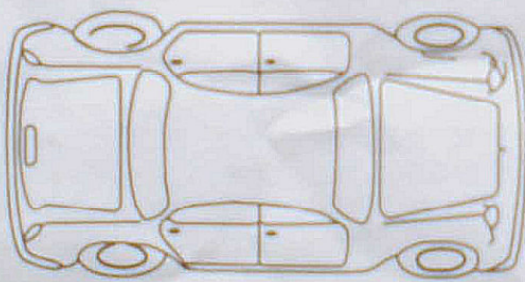
